The course

The concept of Theory of Defense is central to every aspect of NCDC training. Our short program focusing on this concept has been one of our most popular offerings over the last 20 years. Although Theory has been a constant, our methods of communicating it have evolved and this evolution is reflected in the changing titles of the program: originally, **Theories and Themes**; later, **Theories, Themes, and Stories**; and then most recently, **Theories, Stories and Improv**. Reflected in this progression is the fact that this program has become our laboratory for the development of training techniques. Even though we have restored the original name, **Theories and Themes**, this continues to represent the cutting edge of criminal trial skills.

Early registration is encouraged both because of limited enrollment and because of pre-program materials which you will want to consider before arriving in Atlanta.

The two and one-half day program combines intensive small group exercises with faculty presentations, allowing participants to conceptualize and practice the suggested techniques. A video record of each person's performances encourages reflection and continued improvement long after the weekend is over.

Accommodations

This program will be held at the Renaissance Atlanta Hotel-Concourse. The hotel has 24 hour free shuttle service.

NCDC will arrange hotel accommodations for participants, at a special rate of \$90.00 per night single or double occupancy. **Please note:** participants will make payment for all room charges directly to the hotel BUT we make your reservations! Complete the reservation portion of the registration form in this brochure and return it to NCDC. These rates will be available only until March 12, 2012.

A reserved room will be held until **4:00 p.m. Thursday, Apr. 12**. If you will arrive after that time, call us and we will help you guarantee the room for late arrival. If you wish to share a hotel room with another participant to economize, we will **attempt** (but not guarantee) to find you a roommate.

NOTE: The tuition fee does NOT include meals other than continental breakfast.

Tuition

The tuition fee including course materials is \$550.00. **Fees must be paid by Mar. 12, 2012, unless other specific arrangements are made.** A \$25.00 non-refundable registration fee (to be applied to tuition) must accompany registration if not paid in full. No scholarship funds will be available for this program. See the website (www.ncdc.net) for the new summer session reunion discount!
